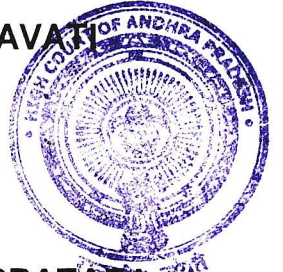

In that view, Police are directed not to proceed further against the Petitioner / Accused No.6 relating to C.C.No.1227 of 2019 on the file of the Court of Judicial First Class Magistrate-cum-Additional Junior Civil Judge, Mangalagiri.
