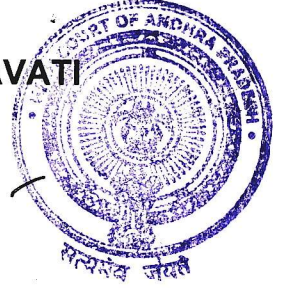

Agraharam Gram Panchayat of Bestavaripeta Mandal as illegal, arbitrary, irresponsible, against to the principles of natural justice apart from being violative of Article 21 of the Constitution of India and consequentially direct the respondents to pay the above amounts forthwith along with interest at the rate of 12% per annum in the interest of justice; ✓

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri KAMBHAMPATI RAMESH BABU, Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
