WHEREAS the Petitioner above named through his Advocate Sri. T DIWAKAR REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or writ or direction more particularly one in the nature of writ of mandamus challenging the impugned proceedings issued by the 4th respondent Vide Rc. No. 3144/C3/2025, dated 13-08-2025, including the consequential proceedings dated 14-08-2025 and 22- 09-2025, as illegal, arbitrary, violative of Articles 14,16 and 21 of the constitution of India, and contrary to G.O.Ms. No.145, General Administration (Ser.D) Department, dated 15.6.2004 and consequently to set aside the same and direct the respondents to irestore the petitioner to the post of LFL Headmaster/PSHM with all consequential benefits, including seniority, pay and promotion benefits, without reference to the reversion made in 2023, and further direct the respondents not to recover any amount from the petitioner pursuant to the impugned proceedings;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri T DIWAKAR REDDY, Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
