

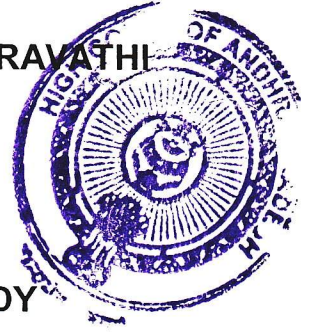

CRL.P. NO. 10886 OF 2018

EXTENDING THE INTERIM ORDER
