Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order, direction or writ, more particularly one in the nature of a Writ of Mandamus declaring the in action of the respondents in initiating the action against the 5th respondent for violating the conditions incorporated in the D-Form patta B42586/77 dated 6-12-1977 by causing obstruction to the cart track as well as the drainage (Murugukondu) situated in Sy.No.164 and

183 of Sivadevuni Chikkala Village, Palakol Mandal, inspite of the representqtions dt.11-11-2013, 7-1-2014, 3-7-2014, 5-11-2014 and 15-12-2014 submitted by the petitioners herein as illegal arbitrary contrary to law and violation of Art.300-A of consequently direct the respondents 1 to 4 to consider the representations submittted by the petitioners and initiate action against the 5th respondent for violating the conditions mentioned in the patta and also to restore cart track and the drainage (Murugukodu) situated in Sy.No.164 and 183 Sivadevuni Chikkala Village, Palakol Mandal to its normal possession.

**IA NO: 1 OF 2016 (W.P.M.P.No.9094 of 2016)**

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents 1 to 4 to see that the 5th respondent not to obstruct the petitioners from using the cart track situated in Sy.No.164 and 183 over the drainage bund Sivadevuni Chikkala Village, Palakol Mandal, West Godavari District, Pending disposal of WP 7126 of 2016, on the file of the High Court.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents 3 and 4 along with the Joint Collector and Superintedent Engineer, Irrigation Department, to implement the proceedings in Rc. **ORDER:**

“The Writ Petitioners in WP Nos.7126 and 43903 of 2016 seek to direct the official respondents to restore the drainage (Murugukodu), situated in Survey Nos.164, 183, 185 and 186 of Sivadevuni Chikkala village, palakol Mandal, to its original position for agricultural and communal purposes.

Learned Assistant Government Pleader for Revenue appearing on behalf of respondent Nos.2 and 3 submits that there are disputes between the Writ Petitioner and unofficial respondents.

Irrespective of the same, respondent Nos.2 and 3 are hereby directed to clear the drainage (Murugukodu), situated in the subject land and restore the same to its normal position and file an affidavit to that extent by the next date of hearing indicating the steps that have taken for clearing Murugukodu.

List the matter on 02.09.2025.”

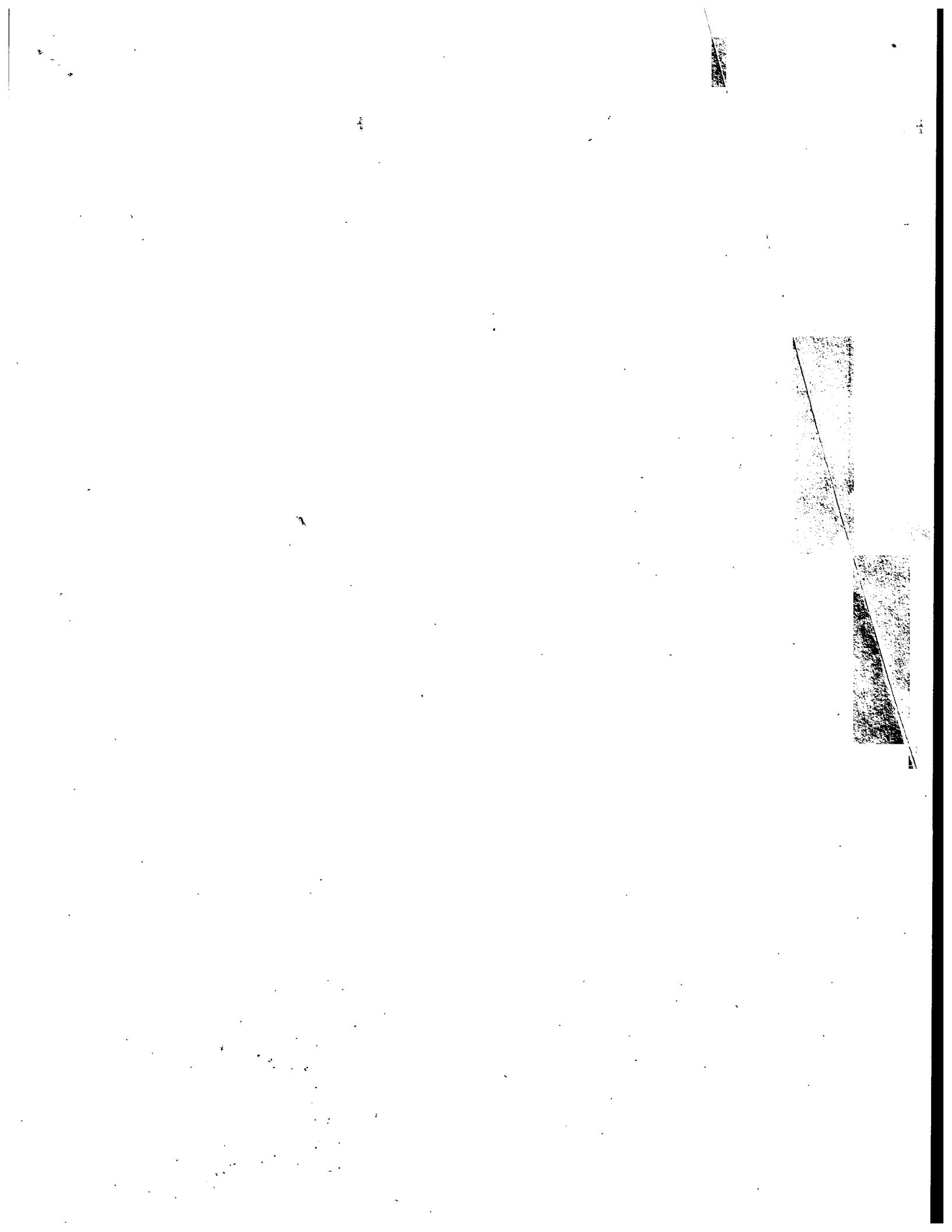
