2. The present petition has been preferred for the
grant of following relief(s):

*“for initiation of a contempt
proceeding against the opposite parties for*





willful and deliberate violation of the judgment/order dated 11.12.2017 passed by the Hon'ble Court in CWJC No. 9639 of 2008."

3. Mrs. Sunita Kumari, learned State counsel submits that due to miscommunication, the Director, Agriculture Department is not present. However, a supplementary show cause has been filed on behalf of the opposite party no.4 and she has taken this Court to the letter no. 2175 dated 25.03.2026 to submit that in compliance with the order passed by the Writ Court as also after dismissal of LPA No. 877 of 2018 and LPA No. 1867 of 2017, seniority list has been released and the name of the petitioner Anil Kumar is there at serial no.9.

4. A copy of the show cause was handed over to learned counsel for the petitioner on 10.04.2026 and there is no rebuttal to it.

5. In that background, granting liberty to the petitioner to agitate the matter, if anything still remains, the petition stands disposed of.
