ORAL ORDER

2 16-03-2026 Heard learned counsel for the petitioners and learned counsel for the State.

2. This writ application has been filed for the following reliefs:-





- (i) *For issuing appropriate direction to the respondent no. 7, Circle Officer, Korha, Katihar to measure the lands situated at Mauza Binodpur, Thana No. 149, Khata No. 7, Plot No. 161, Area 0.97 decimal having boundary, North Md. Sagir, South-Hamida Khatoon, West-Azad Ali, East- Road.*
- (ii) *Also direct the respondent no. 7, the Circle Officer, Korha, Katihar to conclude the measurement record no. 53/22-23 registered for measurement of lands situated at mauza-Binodpur, Thana NO. 149, Khata No. 7, Plot No. 161, Area 0.97 decimal.*
- (iii) *Also direct respondent no. 5 Sub Divisional Officer and Respondent No. 8 Officer-in-Charge of Rautara Police Station to provide police protection in measurement as well as construction of boundary of above mentioned land.*
- (iv) *Grant any other relief(s) to the petitioners as this Hon'ble Court may deem fit and proper.*

3. Learned counsel for the petitioners submits that the petitioners purchased Plot no. 161 of Khata No. 7, Thana No. 149 area 0.97 decimal situated at Mauza Binodpur from respondent no. 9, namely, Nirja Devi, who is the daughter of original land owner, namely, Avdheshwari Prasad Chaudhary through two sale deeds having area 37 and 97 decimals. Thereafter the name of the petitioners were mutated and rent receipts were issued in their favours. The petitioners filed an application for measurement of land on 28.06.2022 which was registered as Measurement Record No. 53 / 2022-23. It is also





submitted that Amin fees was also deposited on 07.07.2022. Thereafter the Circle Officer *vide* Memo No. 1891 dated 30.07.2022 directed the Anchal Amin, Korha to measure the lands of Khata No. 7, Plot No. 161 area 97 decimal and the date was fixed for measurement on 13.08.2022. Since then, the matter is pending and no measurement has been done and further no step has been taken by the Circle Officer as well as Anchal Amin.

4. Having regard to the nature of the grievance of the petitioner, the petitioner is directed to file afresh representation before the Circle Officer, Korha (respondent no. 7) enclosing all the documents and details of the case for measurement of the land in question i.e. Measurement Record No. 53 / 2022-23 within a period of two weeks. Upon filing of such a representation, respondent no. 7, Circle Officer, Korha shall get the land of the petitioner measured in Measurement Record No. 53/2022-2023 positively within a period of two months from the filing of such representation.

5. Accordingly, this writ application is disposed of with the aforesaid direction.
