ORAL ORDER

3 21-04-2026 The petitioner has filed the instant application for
the following relief (s) :-

"1. (i) For issuance of an appropriate writ in the nature of Certiorari for setting aside of the Notification issued vide letter No. 283 dated 05.02.2026, whereby scheduled election of serial 181, Mahadeopur PACS, Block Amarpur has been postponed until further orders on the pretext of "dispute in Voter List" and further direction was given to Respondent No.7 to inform all the





candidates through letter and publicity and the rest of the direction in Notification No. 3319 dated 30.12.2025 would remain same.

(ii) For issuance of an appropriate writ/writs, order/orders, direction/directions in the nature of writ of Mandamus for commanding and directing the respondent Election Authority to adhere with rules/guidelines prescribed in the Rule Book as well as direction issued under Letter No. 3133 dated 04.12.2025 and hold the election.

(iii) For issuance of an appropriate writ/writs, order/orders, direction/directions in the nature of writ of Mandamus for commanding and directing the respondent authorities to accept the final voter list of 2025 published on 26.12.2025 and hold election on same voter list as was duly authorised by the Election Officer Co-Operative Societies) Amarpur after complying the direction/instructions of letter dated 04.12.2025.

(iv) For any other relief/reliefs for which petitioner is entitled in the fact and circumstances of the case.”

2. Learned counsel for the petitioner seeks permission

to withdraw this application.

3. The application is dismissed as withdrawn.
