ORAL ORDER

2 24-04-2026 Heard the parties.

2. The learned counsel for the Bihar Technical Service Commission submits that the similar issue has already been decided by a learned Coordinate Bench of this Court, vide oral judgment dated 21.04.2026, passed in C.W.J.C. No.2937 of 2026, wherein the learned Coordinate Bench, after considering the entire facts, in paragraph no.10 has held as follows:

“10. After going through the provisions of the advertisement and the judgments quoted above, this Court is of the firm view that the condition precedent has already been laid down in the advertisement’s clause 5(ii)(g) which he





petitioners have failed to achieve and only after getting knowledge that they got marks below cut-off, they challenged advertisement in the writ. Petitioners have opted to participate in the examination process and when they failed to achieve the minimum cut-off marks, then only they challenged the same. Particularly, in the light of the law laid down in the advertisement and ratio laid down in various judgments quoted above, this Court is of the firm view that there is no need of any interference in this matter. Hence, this writ petition stands dismissed.”

3. The learned Senior Counsel for the petitioners does not dispute the said legal position.

4. Accordingly, the present writ petition is dismissed in terms of the oral judgment dated 21.04.2026, passed in C.W.J.C. No.2937 of 2026.
