This Letters Patent Appeal has been filed by the appellants challenging the interim order dated 25.03.2026 passed by the learned Single Judge in C.W.J.C No. 4245 of 2026.

2. When the matter was listed on 23.04.2026, since we found that the interim order has been challenged and the case is posted for 27.04.2026, we passed the order directing the parties to co-operate with the learned Single Judge for disposal of the writ petition at an earliest.

3. Learned Senior Counsel appearing for the appellants submitted that the matter was taken up on 27.04.2026, but one interim application was filed by the writ petitioner for certain





relief and accordingly, the case is now posted to 11.05.2026. It is also informed that in the meantime a contempt petition has also been filed seeking compliance of the interim order under appeal.

4. In view of such state of affairs, the Letters Patent Appeal is disposed of so that the parties shall co-operate with the learned Single Judge for disposal of the writ petition on the date fixed.

5. It is made clear that we have not expressed any opinion on the merits of the case.

6. It is expected that the learned Single Judge shall dispose of the matter at an earliest after hearing learned counsel for the parties.
