1. The petitioner has filed the instant application for
the following reliefs:

- “a) To Issue an appropriate writ, order or direction, including a writ in the nature of Certiorari, for quashing the impugned letter no 30-101/2024-1546 dated 15/04/2026 issued by the Respondent no 2 (Annexure P/1) on the ground that the said letter is illegal, arbitrary and without application of mind;*
- b) To Issue an appropriate writ, order or*





direction, including a writ in the nature of Mandamus directing the District Magistrate, Saran to strictly follow the judicial guidelines laid down by Honourable Supreme court in SLP no 12490/2024 for No Confidence motions brought against the Adhyaksha /elected representatives in Bihar

c) Issue any other writ, order or direction as this Hon'ble Court may deem fit and proper in the interest of justice;"

2. Learned counsel for the petitioner seeks permission to withdraw this application.

3. This application is dismissed as withdrawn.
