2. It has been jointly submitted that the issue involved in the present writ petition, has already been decided by the Hon'ble Full Bench of this Court in case of Ravi Shankar Kumar Vs. The State of Bihar & Ors. passed in CWJC No.23831 of 2018 with analogous cases. Both the parties jointly submits that in the light of Hon'ble Full Bench decision, there is nothing left, but learned counsel for the petitioners submits that some of the persons have challenged the said order in SLP(C) No.38217 of 2025 which is pending till date.

3. In the light of the Hon'ble Full Bench decision, the present writ petition is hereby dismissed only with limited liberty to the petitioners that if Hon'ble Court shall decide this case in favour of the petitioners then they may move afresh before this Hon'ble Court.

4. With the aforesaid liberty, the present writ petition stands dismissed.
