2 04-05-2026 Heard Learned Counsel for the petitioners and
Learned Counsel for the State.

2. The present writ petition has been filed with the
following reliefs:-

I. For issuance of writ in the nature of Mandamus or any other appropriate writ for commanding the respondents to appoint the petitioners on the post of Class-IV grade employee pursuant to Advertisement No. 02/99 published by the District Collector, Kishanganj, wherein the petitioners has obtained higher marks in written and physical examination but several candidates who obtained lesser marks than petitioners have been appointed.

II. For issuance of writ in the nature of Mandamus or any other appropriate writ for





commanding the respondents to call for the merit list of the examination against the Advt. 02/99 which was prepared after taking the examination and further issuance of writ in the nature of certiorari to quash the part of the merit list which was illegally prepared by the respondent no. 6.

III. For issuance of a writ in the nature of mandamus or any other appropriate writ(s), order(s), directions(s) upon the respondents to act in accordance with law after complying the principles of natural justice and not to act in a vindictive manner against the petitioner.

3. Learned counsel for the petitioners submits that the petitioners have filed a representation (Annexure-P/16) for fulfilling their grievances in the year 2016, but no decision has been taken till date.

4. Learned counsel for the State, on the other hand, submits that a counter-affidavit has been filed in which stand has been taken that the Vigilance Investigation Bureau, Bihar Patna, found that several irregularities have been found in conducting the examination vide Advertisement No.02/1999 in which overwriting and manipulation in mark sheet and tabulation chart at large scale has been found by Vigilance Investigation Bureau, Bihar, Patna and for which an FIR bearing No.52 of 2019, dated 28.12.2019 has been lodged in Vigilance





Police Station against guilty persons. As such, there is no scope with regard to the petitioner.

5. In the light of the submissions made, the present writ petition is hereby disposed off directing the petitioners to file a fresh representation raising all their grievances before the District Magistrate, Kishanganj (respondent No.4) within 30 days and the respondent No.4 shall take decision in the matter of appointment made in the case of ***Kapil Kumar & Ors. Vs. The State of Bihar & Ors. with other analogous cases*** reported in ***(2020) 1 PLJR 287***, which was approved by Hon'ble Division Bench of this Court in LPA No.1183 of 2023, particularly when, this Court is of the firm view that with regard to advertisement No.02 of 1999 , no relief could be granted to the petitioners as on the said vacancy, there was adverse remarks of the vigilance and FIR has been lodged.

6. With the aforesaid directions and observations, the present writ application stands disposed off.
