(ii) Further for a direction to the respondents to appoint the petitioners on the Post of Touring Veterinary Officer (TVO) on remaining vacant/non joining Post pursuant to Adv. No. 02/2022. Out of 624 post, 283 candidates were selected and only 278 candidates have joined and hence 346 posts are still vacant.

(iii) For any other relief/reliefs for which the petitioner is entitled to get.”
