Without going into the merits or demerits of the





case the present writ petition is disposed of at the stage of admission with the consent of both the counsels.

2. Learned counsel appearing on behalf of the petitioners submits that it would suffice for the present if the Respondents-Bihar Medical Services and Infrastructure Corporation Ltd. is directed to dispose of the representation made by the petitioner dated 08.12.2025 (Annexure P/7) by fixing a time frame.

3. Learned counsel appearing on behalf of the Respondents-Bihar Medical Services and Infrastructure Corporation Ltd. submits that he has no objection if a direction is given to the concerned authority, i.e., Managing Director, Bihar Medical Services and Infrastructure Corporation Ltd. (Respondent No. 4) to consider the representation made by the petitioners and pass necessary orders strictly in accordance with law.

4. Having regard to the above made submission, the present writ petition is disposed of directing the Managing Director, Bihar Medical Services and Infrastructure Corporation Ltd. (Respondent No. 4) to consider the representation made by the petitioner as expeditiously as possibly preferably within a period of 8 weeks from the date of receipt of a copy of this





order. Any decision taken by the authority shall be communicated to the parties.

5. In case the authority comes to the conclusion that the claim of the petitioner is found to be genuine and correct necessary call of action will be taken.

6. With the above directions, the present writ petition stands disposed of.
