| Ashish | <p>Learned counsel for the appellant submits that the deceased was a retired Head Master. He was receiving pension which was considered by the learned Tribunal for assessment of compensation. Apart from this, the learned Tribunal also added Rs.10,000/- per month to his income. According to the appellant the deceased was earning through tuition etc. He further submits that there is no documentary or other evidence barring oral statement of the appellant that the deceased was also earning Rs.10,000/- by imparting tuition. Therefore, the amount of compensation awarded by the learned tribunal is excessive.</p> <p>It is ordered that on appellant's depositing Rs.15,00,000/- out of the total awarded amount before the learned Claims Tribunal within a period of 45 days from today, the recovery of the remaining amount shall remain stayed.
