08/01/2026	Mr. Md. Naqeeb, Advocate on behalf of Mr. Aniruddha Shrivastava, Advocate for the Petitioner. Mr. Suyashdhar Badgaiya, Government Advocate for the Respondents/State. Issue notice to the respondents. Mr. Suyashdhar Badgaiya, Government Advocate accepts notice on behalf of the Respondents/State. Hence, no process fee is required to pay for these respondents. Also heard on I.A. No. 01/2026 which is an application for grant of interim relief. Learned counsel for the petitioner submits that the petitioner is a Teacher of Arts subject. He was transferred under the Rationalization Scheme, 2025 from Government Girls Middle School, Naila to Government Middle School Pakariya (Jhulan), Block – Akalatara. According to his instructions and certificate issued by the Principal Government Middle School, Pakariya (Jhulan), Block – Akalatara, the post of Teacher of Arts subject is not vacant as the Headmaster posted there is of Arts and only the post of Teacher (English) is vacant. The certificate is enclosed along with the writ petition as Annexure P/12. He also contended that according to his instructions, the Principal of the Government Middle School, Naila of Arts subject has retired from service on 30.06.2025 and since then, the post of Teacher (Arts) is lying vacant and therefore, till reply is filed by the Respondents/State, as the petitioner is still working at Government Girls Middle School, Naila, he may be permitted to continue at the present place of posting. On the other hand, learned counsel for the

Dey	Respondent/State submits that in view of the subsequent development as stated by the petitioner, that the post of Teacher (Arts) has become vacant after 30.06.2025, he will file reply to the interim application also. I have heard learned counsel for the parties and perused the records enclosed along with the writ petition. On due consideration of the submission of learned counsel for the parties, facts and circumstances of the case and documents enclosed along with the writ petition, purely as an interim measure, it is directed that the status quo as it exists today with regard to posting of the petitioner shall be maintained by the parties till the next date of hearing.
