1. The petitioner has filed this petition seeking the following relief(s):-

“10.1 That this Hon'ble Court may kindly be pleased to issue an appropriate writ quashing the condition No. 2 of Impugned advertisement dated 20.12.2021 (Annexure P-1) which relates to passing of diploma of Pathology Technician from Govt. Institutions.

10.2 That this Hon'ble court may kindly be pleased to direct the respondents to permit the petitioner for submitting application form having the diploma from Private Institution and registered under Chhattisgarh Paramedical Council.



10.3 That this Hon'ble court may kindly be pleased to quash the impugned advertisement and directed the respondent No. 3 to issue the fresh advertisement as per norms of Indian Medical Council dated 03.06.2020.

10.4 Any other relief, which this Hon'ble Court may deem fit and proper, may also be passed in favour of the petitioner together with cost of the petition."

2. At the very outset, learned counsel for the petitioner would submit that by efflux of time, the present petition has become infructuous, therefore, this petition may be dismissed being rendered infructuous.
