| <b>19/01/2026</b> | <p>Heard Mr. Jitendra Gupta, learned counsel for the applicant.</p> <p>Learned counsel for the applicant submits that the matter was referred for counselling before the learned Family Court. It is contended that the applicant, who is the wife of the non-applicant, had on several occasions expressed her willingness to reside with her husband, i.e. the non-applicant, as is evident from the order-sheets maintained on various dates. It is only on 14.12.2018 that the applicant/wife stated that she did not wish to go along with her husband. However, the learned Family Court, while taking note of the said order-sheet, erroneously concluded that the applicant was living separately from her husband without any sufficient cause and rejected her claim.</p> |
