- 1** By way of this writ petition, the petitioner seeks following reliefs:

“1] That, this Hon'ble Court may kindly be pleased to issue writ/writs, order/orders, direction/directions quashing/setting aside the order/intimation dated 31.12.2025 bearing Reference No. 919 passed by the Chief Municipal Officer Saraipali District Mahasamund Chhattisgarh (Annex.P/1).

2] That, this Hon'ble Court may kindly be pleased to issue writ/writs, order/orders, direction/directions for reconsideration of the technical evaluation of the Petitioner No.1 Joint Venture namely Shree Hari Infraprojects Pvt Ltd/ Ratna Khanij Udyogin Tender No. 178964 (1st Call) issued by Chief Municipal Officer Saraipali District Mahasamund Chhattisgarh and the petitioner may kindly be declared as technically qualified and eligible for Financial Evaluation.

3] That, this Hon'ble Court may kindly be pleased to issue writ/writs, order/orders, direction/directions to the respondent authorities for opening of Financial Evaluation/bid of the Petitioner No.1 in Tender No. 178964 (1st Call).

4] That, this Hon'ble Court may kindly be pleased to grant any other relief(s), which is deemed fit and proper in the aforesaid facts and circumstances of the case.”
