H.L.Sahu	Heard on I.A. No. 01/2026, Application for grant of stay. By impugned award dated 08.10.2025 passed in Claim Case No. H-122/2023, the Tribunal has granted a total compensation of Rs. 51,32,784/- with annual interest @ 6%. The accident occurred on 07.06.2023 and a total compensation of Rs. 51,32,784/- has been awarded in favour of the claimants but till date not a single penny has been deposited in favour of the claimants. Considering all these facts, it is directed that on appellant's depositing 75% of the awarded amount within a period of 30 days from today, the recovery of rest of the award shall remain stayed till the next date of hearing. The claimants are entitled to withdraw the amount to be so deposited by the appellant/insurance company on furnishing an undertaking to return the said amount whenever the Court directs. Accordingly, I.A. No. 01/2026, is allowed to the extent indicated herein-above. List this case for final hearing.
