1. Today the case is listed in default(s), mentioning that the page no. 14, 45 and 46 to be not easily visible/faint/clearly readable.
2. I perused the aforementioned pages. Default(s), as pointed out by the Registry, they are readable and clearly visible, as such default pointed is over ruled.
3. Heard on admission.
4. Learned counsel for the petitioner submits that petitioner is holding the post of Assistant Teacher, posted at Primary School Kharhibadi Block Khadgawan was transferred to Primary School Malakdol Block Bharatpur under rationalization policy. Aggrieved by which petitioner has submitted a representation before District Committee Constituted under rationalization policy vide Annexure P-4 which was rejected vide order dated 28.06.2025. Petitioner thereafter had submitted a representation before Divisional Level Committee and the Divisional Committee considering the grounds raised therein has remitted back the case to District Level Committee for reconsideration. The District Level Committee headed by District Education Officer, MCB (C.G) though observed that the Primary School Kharharibadi, is now coming within the jurisdiction of District Education Officer, Baikunthpur has rejected the claim observing that there is no



ground for modification of order of posting of petitioner which is erroneous. He submits that the District Level Committee of MCB has observed that he is not having any jurisdiction, therefore, the District Level Committee, Baikunthpur, Korea is to take decision on claim of petitioner. Petitioner may be permitted to submit representation before D.E.O, Baikunthpur, District – Korea.

5. Learned counsel for State opposes the submission made by learned counsel for petitioner. However she submits that in view of limited prayer made by learned counsel for petitioner she is having no objection.
6. I have heard learned counsel for the respective parties.
7. On due consideration of submission made by learned counsel for the respective parties, petitioner is permitted to submit fresh representation along with the copy of order of Divisional Level Committee before the District Level Committee, Baikunthpur, Korea and if such a representation is submitted, the concerned authority shall consider and take decision, in accordance with law, expeditiously, preferably within a further period of three weeks.
8. With the aforesaid observation and direction, this writ petition is disposed of.
