1. Petitioner has filed this writ petition, seeking following reliefs:-

“10.1 That, the Hon'ble Court may kindly be pleased to direct the respondent no. 2 to consider case of the petitioner for her posting at where is post of lecturer(Hindi) is vacant i.e. Govt. High School, practising Manjhpara, Kanker, District- North Baster, Kanker, C.G.

10.2 That, this Hon'ble Court may kindly be pleased to direct respondent no. 3 to consider representation



of the petitioner dated 03.11.2025 (Annexure P-5) within stipulated period.

10.3 Any other relief, which may be deemed fit by this Hon'ble Court just and proper in the facts and circumstances of the case may also be provided in favour of the petitioner."

2. Learned counsel for petitioner submits that pursuant to the rational scheme, petitioner was posted from Govt. Higher Secondary School Surdongar to Govt. High School Jamgaon, Block- Keshkal, District- Kondagaon (C.G.) on the post of Lecturer Hindi. When petitioner went to join on 05.06.2025 at the new place of posting, she was informed that post of Lecturer Hindi is not available. Petitioner thereafter, wrote a letter to the District Education Officer i.e. respondent no. 3 on 03.11.2025. Till date no action has been taken on her representation.
3. Counsel for the State submits that looking to nature of the grievances as raised and further that the petitioner has already submitted representation it will be considered in accordance with law.
4. Considering submissions made by counsel for respective parties and also the fact that petitioner in compliance of order of her posting under rationalization scheme has went to join new place of posting at Govt. High School Jamgaon, Block Keshkal, District Kondagaon, C.G., but according to her post of Lecturer Hindi is not vacant there and representation is still pending for consideration before respondent no. 3, therefore, I find it appropriate to dispose of this writ petition at this stage directing respondent no. 3 to take decision on pending representation expeditiously in accordance with law, preferably within a period of three weeks from the date of receipt of order of this Court.
5. Accordingly, the present writ petition is disposed of with the aforesaid direction.
