04/02/2026	Mr. F.S. Khare, Adv. for the petitioner. Mr. Vinay Pandey, Addl. Adv. General for the respondent No. 1. Ms. Monal Sai, Tehsildar, Kharsiya, Distt. Raipur also appears through VC. Heard on merit. Issue notice to the respondents through both the modes on payment of process fee within a week. The Addl. Adv. General accepts notice on behalf of respondent No. 1, hence issuance of notice to it is dispensed with.



	Process fee be paid only for respondent No. 2. Also heard on I.A. No. 1/2026, application for grant of interim relief/stay. Learned counsel for the petitioner would submit that, the petitioner is an owner of land bearing Khasra No. 107/2/1 area 50 decimal situated at village Madanpur, Patwari Halka No. 21, Tahsil Kharsiya, Distt. Raipur which is a diverted land. He further submits that, the adjacent land of respondent No. 2 is Khasra No. 106 and 107/1. The issue of correction of map has been dealt by the Tehsildar, Kharsiya vide order dated 3-7-2023 (Annexure P-2), thereafter map was corrected. The appeal preferred by respondent No. 2 against the order of Tehsildar, Kharsiya has also been dismissed by the Sub Divisional Officer vide order dated 3-9-2024 (Annexure P-4), which has also been upheld by the Commissioner, Bilaspur and the matter is pending before the Board of Revenue, despite all this, respondent No. 2 filed application dated 9-1-2026. Only on the basis of that application, the Tehsildar Kharsiya has passed the impugned order Annexure P-1 dated 9-1-2026 which is 'Kam Roko Adesh', that too, without registration of revenue case. Hence, learned counsel submits that, effect and operation of the impugned order Annexure P-1 may be stayed. Issue notice to the respondents on the interim application also as above. Learned Addl. Adv. General appearing for the respondent no. 1 seeks time to file reply to the main petition as well as the interim application.
