	Appellant. Heard on I.A. No. 01/2026 for condonation of delay in filing the appeal. Upon due consideration and for the reasons mentioned in the application, I.A. 01/2026, is allowed subject to payment of a cost of Rs.12,000/- by cheque to one of the claimants within a period of 10 days from today before the Tribunal. The delay of 116 days in filing the appeal is hereby condoned. Heard on admission. Admit. Also heard on I.A. No. 02/2026 for grant of Stay/interim relief . By the impugned award dated 09.07.2025 passed in Claim Case No. 80/2023 the Tribunal has granted a total compensation of Rs. 3,30,000/- with annual interest @ 7% to the claimants. Learned counsel for the appellant submits that the impugned award is full of illegality, perversity and anomalies, so the instant appeal has every possibility of being allowed by this Court. In view of above, it is directed that on appellant's depositing 80% of the awarded amount within 30 days from today, the recovery of rest of the award shall remain stayed till the next date of hearing.

	The claimants are entitled to withdraw the amount to be so deposited by the appellant Company on furnishing undertaking to return the said amount whenever the Court directs. Accordingly, I.A. No. 02/2026, is allowed to the extent indicated herein-above. The receipts regarding deposits of payment of cost of Rs12,000/- as also the 80% of the award amount directed by this Court shall be filed by the next date of hearing. Let notice be issued to the respondents by ordinary as well as speed post. PF be paid within 07 days. Call for the records of the Tribunal. List this case along with MAC No. 561/2026.
