30.6.2021	Shri G.S. Patel, counsel for the Appellant. Shri Ankur Agrawal, counsel for Respondent Nos. 1 to 3. None for Respondent Nos. 4 to 6, though served. Heard on I.A.No.3/2021, an application seeking appropriate direction to the concerned executing court for disbursement of the award amount under appeal to the claimants. Vide order dated 06.03.2018, this Court while entertaining



the application for grant of stay, marked as I.A.No.1/2018, has been directed as under :

“Subject to the appellant depositing an amount of Rs.50,00,000/- within a period of 30 days from today in addition to what has already been deposited, the execution of the remaining part of the impugned award shall remain stayed until further orders.”

In view of the aforesaid direction, this Court has stayed the remaining part of the award under appeal and for execution of the rest, an appropriate application has already been moved by the claimants before the concerned executing court on 25.1.2019, marked as Annexure-A. In view of that, the application as made herein seeking appropriate directions to the concerned executing court for disbursement of the award amount under appeal is rather misconceived in nature and therefore, deserves to be and is hereby rejected.

I.A.No.3/2021, thus, stands disposed of.

Post this matter for final hearing in its due course.
