	all three matters are heard together on application for interim relief (IA No.1/2026). Learned counsel for the petitioners submit that as per provision of section 48(7)(b) of the Chhattisgarh Cooperative Societies Act, 1960, the criteria with regard to availing 'minimum level of services' shall be as fixed by the by-laws of the concerned Society. However, by the impugned order dated 24.09.2025 (Annexure-P/1 in all three cases) and order dated 12.12.2025 (Annexure-5 in WPC No.1032/2026 & WPC No.1047/2026 only), the Deputy Registrar, Cooperatives Societies, Raipur has fixed the criteria of 'minimum level of services' in contravention of the provisions under the Chhattisgarh Cooperative Societies Act, 1960. At this stage, learned State counsel seeks sometime to file reply to interim applications as well as on main petition. Having considered submission of learned counsel for the parties and considering the documents placed with the petition, purely as an interim measure, it is directed that the effect and operation of the impugned order dated order dated 24.09.2025 (Annexure-P/1) and subsequent order dated 12.12.2025 (Annexure-5), respectively, shall remain stayed till the next date of hearing.
