"10.1 That this Hon'ble court may kindly be pleased to set-aside the order dated 16.02.2026 (Annexure P/1).

10.2 That, the Hon'ble Court may kindly be pleased to set-aside the order dated 04.09.2025 (Annexure P/6), order dated 01.07.2025 (Annexure P/5).

10.3 That, this Hon'ble Court may kindly be pleased to set aside the order dated 02.06.2025 (Annexure P-3), whereby the petitioner has been declared surplus under the Rationalization Scheme of the Government and posted at Govt. Middle School Raja Devri, Block Kasdole, District Balodabazar-Bhatapara (C.G.).

10.4 That, this Hon'ble Court may kindly be pleased to set aside the order dated 15.01.2026 (Annexure P-9).

10.5 That, this Hon'ble Court may kindly be pleased to direct the respondent authorities to allow the petitioner to work in the Govt. Middle School Tonatar, Block Bhatapara, District Balodabazar-Bhatapara (C.G.) or the petitioner may kindly be posted at Govt. Middle School Mirgi, Block Bhatapara, District Balodabazar-Bhatapara (C.G.).
