**Hon'ble Shri Justice Bibhu Datta Guru****Order on Board****16/06/2026**

1. At the outset, learned counsel appearing for the respondent submits that in compliance with the order dated 06.10.2025 passed by this Court in WPS No. 10856 of 2025, the representation submitted by the petitioner has already been considered and decided vide order dated 16.04.2026. It is, therefore, contended that no case of contempt survives for consideration.
2. Perused the order dated 16.04.2026. From a perusal thereof, it appears that the representation of the petitioner has been duly considered and decided by the competent authority. Thus, the direction issued by this Court stands complied with.
3. In view of the aforesaid compliance, this Court is of the opinion that no case of wilful or deliberate disobedience of the order passed by this Court is made out warranting continuation of the present contempt proceedings.
4. Accordingly, the contempt petition is disposed of and the rule is discharged. However, the petitioner shall be at liberty to avail such remedy as may be available to him in law, if he is still aggrieved by the order dated 16.04.2026.
