1. The present writ petition has been filed by the petitioner seeking the following relief(s):

“a) Call for the entire records pertaining to the present case.

b) Hold and Declare that the Additional Terms & Conditions of impugned Notice Inviting Tender (NIT) dated 19.02.2026 (**ANNEXURE – P/1**) creates a Hostile Discrimination between the MSMEs on the basis of their Place of Registration which is impermissible in law.

c) Cancel the impugned Notice Inviting Tender (NIT) dated

19.02.2026 (**ANNEXURE -P/1**) on the basis of Clause 7 of the Notification dated 01.09.2025 issued by the Government of Chhattisgarh (**ANNEXURE – P/15**).

- d) Grant the cost of the petition to the Petitioners.
 - e) Grant any other relief as deemed fit and proper in the facts and circumstances of the case.”
2. Learned counsel for the petitioner states that he wants to withdraw the present petition as necessary amendment has been notified by the State Government vide notification dated 9 December, 2025 and he may be granted liberty to challenge the said notification.
3. Accordingly, the present petition is dismissed as withdrawn with the aforesaid liberty.
