Order on Board

1. Present MCC has been filed for restoration of Writ Petition (S) No.10511/2019, which was disposed of by this Court on 08.12.2025 passed in WPS No.10511 of 2019 and other connected matters.

2. Learned counsel for the applicants submits that on account of incorrect statement made by State counsel appeared in WPS No.10511/19 that promotion has already been granted to the petitioners, said writ petition along with other connected matters, i.e. WPS No.298/2020 & WPS No.08/2020 was disposed of. However, no promotion has been granted to the petitioners, hence, it is prayed that WPS No.10511/2019 (Pramod Kumar Dewangan & Ors. Vs. State of Chhattisgarh & Anr.), which was represented by them, may be restored to its original number, as grievance of the petitioners has not been redressed.

3. Perusal of the Order dated 08.12.2025, whereby aforesaid writ petitions were disposed of shows that, on the date of hearing Dr. Sanjay Guhey, the



then District Education Officer Baloda Bazar-Bhatapara was also present in person. He is present today also. Dr. Guhey submits that, due to mistake, an incorrect statement was made before the Court that the petitioners had already been granted promotion, whereas, in fact, the matter relating to their promotion was under consideration. He submits that the said statement was made inadvertently and tenders his apology for the same.

4. Learned counsel appearing for the State/respondent No.1 submits that on account of incorrect statement made on behalf of the State, WPS No.10511/19 and other connected matters have been disposed of, therefore, he has not objection in allowing the instant MCC.

5. Having considered the aforesaid submissions made by learned counsel for both the parties, present MCC is allowed. The Order dated 08.12.2025 passed by this Court in WPS No.10511/19 and other connected matters is hereby recalled to the extent it relates to WPS No.10511/19 (Pramod Kumar Dewangan & Ors. vs. State of Chhattisgarh & Anr.).

6. The Registry is directed to restore WPS No.10511/2019 (Pramod Kumar Dewangan & Ors. vs. State of Chhattisgarh & Anr.) to its original number and list the same before the appropriate Bench.

7. Accordingly, MCC stands disposed of.

8. Pending interlocutory application(s), if any, stands disposed of.
