With the consent of the parties, the case is heard finally.

1. Learned counsel for petitioners submits that petitioners have filed a writ petition bearing WPS No. 535 of 2026 which came up for hearing on 19.01.2026 and was disposed of directing the respondents therein to consider and take decision on the representation submitted by petitioners, however, in the cause title of the said writ petition the description of the petitioners therein was wrongly mentioned and it could not be rectified till the passing of the order i.e. till 19.01.2026. Due to inadvertent, petitioners could not avail the fruitful outcomes of the order passed by this Court in WPS No. 535 of 2026.
