1. Petitioner has filed this writ petition seeking following reliefs:-

“10.1. That this Hon’ble Court may be pleased to order respondents to issue order to regularized service of petitioner from first date of appointment i.e. 16.12.1996 on the date of taking over charge as has been ordered vide annexure P-3 in case of Aatma Ram Joshi.

10.2. Any other relief which may be suitable in the facts and circumstances of the case, may also be granted.”

2. Learned counsel for the petitioner submit that at this stage he is not pressing this petition on merits and is only seeking permission to submit fresh comprehensive representation along with all supporting documents before the respondents and concerned respondents be directed to take decision on the representation to be submitted by the petitioner at the earliest.
3. Counsel for the State submits that in view of the limited prayer made by counsel for the petitioner, he is having no objection.
4. On due consideration of submission of the learned counsel for the parties and facts and circumstances of the case, without expressing any opinion on merit of the case, this writ petition at this stage is disposed of permitting the petitioner to submit fresh comprehensive representation along with all supporting documents before respondents No.1, 2 & 3 and in the event, such representation is submitted, concerned authorities shall consider and take decision on the same in accordance with

law, expeditiously preferably within a further period of 4 months from the date of receipt of the representation.

5. With the aforesaid observation and direction, this writ petition stands finally **disposed of**.
