1. By way of this petition, the petitioner has prayed for following reliefs:-

“a. Issue an appropriate writ, order or direction, quashing and setting aside the order dated 16/09/2025 passed by the Additional Collector, District Sakti (Chhattisgarh) in the proceedings initiated by the Petitioners, whereby the said authority terminated/dismissed the proceedings, being illegal, arbitrary and without jurisdiction.

b. Issue an appropriate writ, order or direction directing the Respondent authority to produce the entire record(s) pertaining to the matter at hand.

c. Issue an appropriate writ, order or direction directing the Additional Collector, District Sakti (Chhattisgarh) to restore and application dated adjudicate the Petitioners'



07/05/2025 on merits in accordance with law.

d. Issue an appropriate writ, order or direction, remanding the matter back to the Additional Collector, District Sakti (Chhattisgarh) for fresh consideration and decision on merits, in accordance with law.

e. Pass any other order(s), direction(s), or relief(s) which this Hon'ble Court may deem fit and proper in the facts and circumstances of the case, in the interest of justice.

And for this act of kindness, the Petitioner, as in duty bound, shall ever pray.”

2. Learned counsel for the petitioner after arguing for some time seeks permission of this Court to withdraw this petition with liberty to approach before the concerned Collector while filing appropriate application.
3. No objection has been raised from other side.
4. Accordingly, the writ petition is dismissed as withdrawn with the aforesaid liberty.
