No. 01/2026 which is an application for grant of interim relief. Learned counsel for the petitioner submits that in the advertisement-2025 (Annexure P/2), there is specific clause with respect to preparing of the merit list by the respondents employer after adding the marks of experience. However, the merit list which is forwarded by the Respondent No. 4 has been accepted by the Respondents-State/Employer and is proceeding to conclude the recruitment proceedings. On the other hand, learned counsel for the Respondents/State submits according to her instructions, the merit list which is forwarded by the Respondent No. 4 has been considered and it is being proceeded on the basis of the merit list forwarded by the Respondent No. 4. She also submits that according to her instructions, none of the applicants have submitted the experience certificate which can be considered for grant of additional marks. On due consideration of the submission of learned counsel for the parties, facts and circumstances of the case and
