1. Petitioner has filed this petition seeking following reliefs :-

“10.1 That, this Hon'ble Court may kindly
be pleased to issue a writ in the nature of
mandamus quashing the impugned
transfer order dated 05.06.2025
(Annexure P/1) and the rejection orders



dated 30.06.2025 and 15.09.2025
(Annexure P/2 colly).

10.2 That, this Hon'ble Court may kindly be pleased to issue a writ in the nature of mandamus directing the Respondents to allow the petitioner to continue in his present posting at Government Middle School, Kolar, Block Abhanpur or to post him in any of the vacant posts in Block Abhanpur (Sarkhi, Murra, Raveli, Khatti etc.) considering his subject (Hindi) and family circumstances.

10.3 That, this Hon'ble Court may kindly be pleased to grant any other relief, as it may deems fit and appropriate.”

2. Learned counsel for petitioner submits that petitioner while working on the post of Teacher (LB) and posted at Government Middle School, Kolar, Block – Abhanpur, District Raipur is transferred to Government Middle School Konari, Block – Tilda, District Raipur under rationalization policy. He contended that aggrieved with posting of petitioner under rationalization policy in another block, petitioner has submitted representation before the Divisional Level Committee constituted under rationalization policy which came to be dismissed against which petitioner submitted representation before the State Level Committee headed by Director of Public Instructions, which is pending consideration, therefore, direction be issued to respondent No.2 to consider and take decision on the representation submitted by petitioner at the earliest.
3. Learned State counsel submits that in view of the limited prayer made by learned counsel for petitioner, he is having no objection.
4. On due consideration on the submission of learned counsel for respective parties, nature of grievance raised, this writ petition at this stage is disposed of directing respondent No.2 to consider and take



decision on the representation dated 20.02.2026 in accordance with law expeditiously preferably within further period of two months from the date of receipt of order.

5. With the aforesaid observations and directions, this petition stands disposed of.
