Learned counsel for the petitioner would submit that the petitioner is challenging the impugned order dated 23.04.2026 (Annexure P-1) issued by respondent No.6-Divisional Forest Officer, Sarangarh-Bilaigarh Division, which directs the petitioner to remove his house within 24 hours. Therefore, it is prayed that kindly be pleased to allow the instant application and direct the respondent No.6 to not demolish the house of the petitioner and stay the operation and execution of the impugned order dated 23.04.2026 (Annexure P-1) till final decision of the case.

Learned State counsel opposes the submission made by learned counsel for the petitioner.

I have heard learned counsel for the parties and perused the material available on record.

Considered the facts and submissions advanced by learned counsel for the parties.

Since the matter relates to demolition of home where the petitioner is residing with his family. Therefore, purely as an interim measure, the effect and operation of impugned order dated 23.04.2026 (Annexure P-1) issued by respondent No.6-Divisional Forest Officer, Sarangarh- Bilaigarh Division, District Sarangarh-Bilaigarh (C.G.) shall remain stayed till the

next date of hearing, so far as it relates to the petitioner only. Further, respondent No.6 is directed that he shall not take any coercive steps against the petitioner including removal of encroachment till the next date of hearing.
