1. The petitioner has filed the present petition seeking the following relief(s):-

“1. To issue a writ, order or any other appropriate direction under Article 226 of the Constitution of India to direct Respondent No. 2 & 3 to preserve the articles related to the case till the adjudication of the closure report which is pending consideration before the Ld. Court of Chief Judicial Magistrate / Judicial Magistrate First Class, District – Raipur in the Case Filing Number 18868 / 24, and/or;

10.2 To issue an appropriate order / direction for adjudication of the applications filed by Petitioner before the Ld. Court of Chief Judicial Magistrate / Judicial Magistrate First Class, District – Raipur in the Case Filing Number

18868 /24 which is still pending consideration due to non-filing of reply by Respondent No. 3; and/or,

10.3 To pass any other or further order(s) as this Hon'ble Court may deem just and proper in the facts and circumstances of the present case.”

2. Learned counsel for the petitioner submits that the petitioner who are intervener filed an application against the closure report on 06-07-2024 and the State has been given time by the learned Magistrate to file its reply and since then their application has not been decided. He further submits that next date fixed in the matter before the concerned Court is 25-06-2026.

3. In view of the submission made by learned counsel for the petitioner, the present petition is disposed of with a direction to the concerned Court to decide the application of the petitioner filed on 06-07-2024 and pending in the Case Filing Number 18868 /24, within a period of six weeks from 25-06-2026.
