Balram	Ms. Ruchi Nagar, Dy.G.A. for State-respondents. Heard. Issue notice to respondents. Learned State counsel accepts notice on behalf of respondents, hence, process fee is not required to be paid. She prays for and is granted four weeks time to file reply. Also heard on I.A. No.1, which is an application for grant of interim relief. Learned counsel for petitioner submits that petitioner was appointed on the post of Assistant Teacher in the year 2021 as physically handicapped candidates. Petitioner at the time of his appointment has produced original disability certificate issued by competent authority, which was verified and only thereafter, appointment order was issued. Respondents miss-interpreted the order of this Court passed in W.P.(PIL) No. 36 of 2023 has issued letter dated 12.05.2023 to petitioner to produce fresh disability certificate, which is contrary. Learned State counsel submits that she will also file reply to the application for grant of interim relief. Considering the facts and circumstances of the case and the submission of learned counsel for parties, purely as an interim measure, it is directed that no coercive steps shall be taken against petitioner, till the next date of hearing.
