Learned counsel for the petitioner submits that the petitioner was appointed as Assistant Professor under respondent No.4 in Government Engineering College, Raipur and he was promoted to the post of Professor in the year 2015. The petitioner then filed an application before the respondents, making a prayer to forgo the promotion to the post of Principal/ Additional Director. Thereafter, the respondent authorities has

passed the impugned order (Annexure-P/1) dated 28.12.2021 and given promotion to the petitioner. The petitioner is still continuing in his previous place of posting and he wants consideration on his application praying to forgo the promotion passed by the respondents side. Hence, it is prayed that the petitioner may be granted an interim protection.

Learned State counsel representing for respondents No.1 to 3 opposes the submissions and prays for time to seek instructions.

Notice be issued to respondent No.4. P.F. be paid as per rules.

In the meanwhile, it is ordered that, in case, the impugned order has not been implemented till date, then implementation of the same shall remain stayed until the next date of hearing.
