21.06.2023	Mr. Anand Shukla, counsel for petitioner. Mr. R.K. Bhagat, Dy.G.A. for State-respondents. Heard. Issue notice to respondents. Learned State counsel accepts notice on behalf of respondents, hence, process fee is not required to be paid. He prays for and is granted four weeks time to file reply. Also heard on I.A. No.1, which is an application for grant of interim relief. Learned counsel for petitioner submits that petitioner participated in the recruitment process for appointment on the post of

Balram	Veterinary Assistant Surgeon and he was selected and appointed in physically handicapped quota pursuant to the disability certificate issued by the District Medical Board, Bilaspur. After the appointment of petitioner, some complaint was made stating that the disability certificate submitted by petitioner is forged. Taking cognizance on the complaint, respondents department constituted Committee for investigating into the complaint and as per the report submitted by the Committee, certificate submitted by petitioner was found to be valid. It is also the submission of learned counsel for petitioner that based on the order passed in W.P.(PIL) No. 36 of 2023, respondent No.4 had issued letter directing petitioner to appear before the Medical Board vide letter dated 24.05.2023. Petitioner in compliance of letter issued by respondent No.4 submitted himself before the District Medical Board, Bilaspur and the District Medical Board, issued certificate on 06.06.2023. Respondent No.3 again wrote letter to petitioner on 29.05.2023 observing the same ground that petitioner has to appear before the said medical board in terms of order passed in W.P.(PIL) 36 of 2023, which is not only arbitrary but also the action of respondent causing harassment to him. Learned State counsel submits that he will also file reply to the application for grant of interim relief. Considering the facts and circumstances of the case and the submission of learned counsel for parties, purely as an interim measure, it is directed that no coercive steps shall be taken against petitioner, till the next date of hearing.
