No.1/2026, an application under Section 430 of BNSS for suspension of sentence and grant of bail.</i> <i>By the impugned judgment of conviction and order of sentence dated 05.05.2026 passed in Sessions Trial No. 26/2025 by the Sessions Judge, Balrampur, Place Ramanaujganj, District Balrampur-Ramanaujganj (C.G.), appellant has been convicted and sentenced in the following manner with a direction to run the jail sentences</i>

concurrently:-

Conviction	Sentence
Under Section 118 (1) of BNS, 2023	R.I. for 1 year and fine of Rs.500/-, in default of payment of fine further R.I. for 30 days.

Learned counsel for the appellant submits that total period of sentence awarded to the appellant is of 1 years and during the trial he was on bail and even after his conviction and sentence, learned trial Court has granted bail to the appellant for a limited period. He further submits that final hearing will take its own time, therefore, the appellant may be enlarged on bail.

On the other hand, learned counsel for the State opposes.

Considering the submissions made by learned counsel for the parties and total period of sentence awarded to the appellant and further, the fact that during the trial, he was on bail and final adjudication of the appeal will take its own time, therefore, I am inclined to release the appellant on bail.

It is directed that the substantive jail sentence imposed upon the appellant shall remain suspended during the pendency of this appeal and he shall be released on bail on his furnishing a personal bond in the sum of Rs.25,000/- with one surety in like sum to the satisfaction of the trial Court for his appearance before the Registry of this

	<i>Court on 10.08.2026. He shall thereafter appear before the trial Court on a date to be given by the Registry of this Court and shall continue to appear there on all such subsequent dates as are given to him by the said Court, till disposal of this appeal.</i> <i>Accordingly, I.A. No.1/2026, application for suspension of sentence and grant of bail is allowed.</i> <i>Also heard on I. A. No. 2/2026, an application for hearing the case during summer vacation as well as I.A. No. 3/2026, an application for urgent hearing.</i> <i>On due consideration, both the applications(I.A. No. 2/2026 and I.A.
