1. Heard.
2. By way of this writ petition, the petitioner has sought following reliefs:-

10.1 That, the Hon'ble Court may kindly be pleased to allow this petition and directed the respondent No.3 District Education Officer Office of DEO Collectorate Korba District Korba, C.G. to comply with the order passed by the respondent NO.5 Joint Director Education Department Bilaspur and posted the petitioner either in a no teacher school or single teacher school.

10.2 That, any other relief which this Hon'ble Court deems fit and proper may also kindly be granted to the petitioner in the interest of justice along with cost of the petition."

At the very outset, learned counsel for the petitioner as well as the learned State counsel on instruction would jointly submit that petitioner has given consent for his posting in Government Primary School, Jambahar, Development Block Podi Uproda, as such, the Authorities concerned may be directed to pass appropriate order with regard to posting of the petitioner at Government Primary School, Jambahar, Development Block Podi Uproda.
