Meanwhile, purely as an interim measure, it is directed that the effect and operation of the impugned award dated 06.04.2019 passed by the 3rd Additional Motor Accident Claims Tribunal, District Bilaspur (C.G.) in Claim Case No.582/2015, shall remain stayed till the next date of hearing, subject to appellant's depositing a sum of Rs.4,00,000/- (Four Lakhs Only) of the award under appeal before the concerned Executing Court within a period of 45 days from today.

The Respondent No.1/Claimant shall be entitled to withdraw the same without furnishing any kind of security before the concerned Executing Court.

It is made clear that if any of the condition is violated, then this order shall lose its efficacy and the award impugned shall become executable forthwith.
