1. The petitioner has filed this petition seeking the following relief(s):-

“10.1 It is prayed that this Hon'ble Court may kindly be pleased to call for the entire records concerning the present selection, and the comparative results, for its kind perusal.

10.2 This Hon'ble Court may kindly be pleased to issue an appropriate writ quashing and setting aside the order dated 02/01/2021 (Annexure P-1) issued by Respondent No. 2.

10.3 This Hon'ble Court may kindly be pleased to issue an appropriate writ in the nature of mandamus directing respondent No. 1 to 3 to cancel the appointments of the private respondents given on the post of lecturer subject Physics (Annexure P-2) in the light of the circular dated 13.09.2021 (Annexure P-9) issued by respondent no. 1 to 3.

10.4 Any other relief / relief's which this Hon'ble Court may think fit and proper in the facts and circumstances of the case, with cost of the petition may also be pleased to be granted to the petitioner.”

2. Since there is no representation on behalf of the petitioner even in two rounds, this Court is left with no other option except to dismiss the petition for want of prosecution.
3. Accordingly, the petition is **dismissed** for want of prosecution.
