Issue notice to respondent No.5 only, on payment of P.F. as per rules. Also heard on I.A.No.01/2021, an application for grant of interim relief. Learned counsel appearing for the petitioner submits that by virtue of the order impugned dated 07.10.2021 (Annexure P/1), Respondent No.3 - the Chief Conservator of Forest has posted the petitioner from Range Office, Gaurella to Divisional Forest Office, Marwahi without following the instructions issued by the



Principal Chief Conservator of Forest dated 08.12.2020. He, therefore, prays for staying the effect and operation of the order impugned dated 07.10.2021, pending decision of this petition.

Let notice of this application be also issued to said respondent, as above.

Meanwhile, purely as an interim measure, it is directed that the effect and operation of the order impugned dated 07.10.2021 (Annexure P/1) passed by respondent No.3 – Chief Conservator of Forest, Bilaspur Circle, Bilaspur shall remain stayed till the next date of hearing.

Post this matter immediately after 5 weeks for consideration on admission as well as on I.A.No.01/2021.
