1. The petitioner has filed this petition seeking the following relief(s):-

"10.(a) To call for the records pertaining to the recruitment on post of Advisor (Geology) under advertisement dated: 03/04/2021 from the respondent authorities.



10.(b) To set aside the impugned appointment order dated: 28/10/2021 as well as entire selection process for the subject post.

10.(c) To grant liberty to the petitioner to apply for the post in the eventuality fresh advertisement is issued exempting the age bar.

10.(d) Cost of the present petitioner may also be awarded.

10.(e) Pass any other further order(s) as this Hon'ble Court may deem fit and proper in the facts and circumstances of the case and in the interest of justice."
