10/11/2025	Mr. Rahul Mishra, counsel for the petitioner. Mr. Suyashdhar Badgaiya, Deputy G.A. for the State/respondents. This petition has been filed by the petitioner, who was working as Assistant Teacher, assailing the transfer order dated 02.06.2025 (Annexure-P/4), whereby he has been transferred from Govt. Primary School Morga, Block Manendragarh, District Manendragarh-Chirmiri-Bharatpur (C.G.) to Govt. Primary School, Chhatauda, Block Bharatpur, District Manendragarh-Chirmiri-Bharatpur (C.G.), in view of the rationalization scheme. Learned counsel for the petitioner would submit that the petitioner cannot be treated as surplus, as respondent No.7 has joined the present place of posting on 15.12.2015, whereas the petitioner joined the present place of posting on 19.09.2014. He would further submit that the reason assigned by the respondent authorities for rejecting the representation is not in accordance with the subject policy. He further submits that respondent No.7, who was working as the Assistant Teacher (LB) at Govt. Primary School Judwanipara, which was closed in the year 2015, was thereafter posted at the present place of posting. However, the State Government has wrongly taken his date of joining as 23.03.2009. He would further submit that in view of the above, an

interim stay may be granted in favour of the petitioner.

Considering the aforesaid facts of the case, the impugned transfer order (Annexure P/4) issued to the petitioner on account of the Rationalization Scheme shall remain stayed. The respondent authorities are directed to permit the petitioner to join and discharge his duties at his present place of posting without any hindrance.
