1. Learned Prosecutor submits that the matter is now listed before the learned ASJ for recording of the testimony of the prosecutrix on 12.07.2024 and the petition be listed thereafter for addressing the arguments.
2. It is hereby clarified that the complainant shall not take any unnecessary adjournments and shall appear before the learned ASJ for recording of her statement. The learned ASJ may also make an endeavour to expeditiously record the testimony of the prosecutrix.
3. Learned counsel for the complainant as well as learned Addl. Standing Counsel has referred to the Order dated 27.04.2024 in W.P.(CRL.)10/2023, wherein the Predecessor of this Court had directed that the Trial Court may fix the date in the trial after the next date before this Court i.e. 19.07.2023. That order was only for that particular date and it is hereby clarified that it is no impediment for the learned ASJ to continue with the trial of the present case.
4. It is also made clear that in case the testimony of the complainant/prosecutrix gets concluded before the next date fixed before this Court, the party shall be at liberty to file an application for early hearing.
