1. In compliance with the order dated 1<sup>st</sup> April, 2025, it is claimed by the acquiring body, i.e. the Delhi Development Authority ('DDA'), that the chart categorizing the matter has been submitted to the Registry.
2. Respective counsels appearing for the petitioners submit that they are yet to be informed about the categorization of their matters made under a particular head.

8. List these matters on 11<sup>th</sup> November, 2025 before this Court.
9. We further clarify that the pleadings in relation to the applications moved by the parties shall also be completed by the said date.
10. The date already fixed in ***W.P.(C) 9549/2015*** before the Registrar, i.e., 25<sup>th</sup> September, 2025, stands cancelled.
